

# Optocoupler, Phototransistor Output, High Reliability, 5300 V<sub>RMS</sub>



#### **DESCRIPTION**

The 110 °C rated VO618A feature a high current transfer ratio, low coupling capacitance and high isolation voltage. These couplers have a GaAs infrared diode emitter, which is optically coupled to a silicon planar phototransistor detector, and is incorporated in a plastic DIP-4 package.

The coupling devices are designed for signal transmission between two electrically separated circuits.

The couplers are end-stackable with 2.54 mm spacing.

Creepage and clearance distances of > 8.0 mm are achieved with option 6. This version complies with IEC 60950 (DIN VDE 0805) for reinforced insulation up to an operation voltage of 400  $V_{RMS}$  or DC. Specifications subject to change.




Fig. 1 - Total Power Dissipation vs. Ambient Temperature




Fig. 2 - Test Circuit, Non-Saturated Operation




Fig. 3 - Test Circuit, Saturated Operation




Fig. 4 - Switching Times




Fig. 5 - Forward Voltage vs. Forward Current




Fig. 6 - Collector Current vs. Collector Emitter Voltage (non-saturated)




Fig. 7 - Collector Emitter Current vs. Ambient Temperature




Fig. 8 - Collector Current vs. Collector Emitter Voltage (saturated)




Fig. 9 - Collector Emitter Voltage vs. Ambient Temperature (saturated)




Fig. 10 - Normalized Current Transfer Ratio vs. Ambient Temperature (saturated)




Fig. 11 - Normalized Current Transfer Ratio vs. Ambient Temperature (non-saturated)




Fig. 12 - Current Transfer Ratio vs. Forward Current (saturated) normalized to 1 mA at 25 °C




Fig. 13 - Current Transfer Ratio vs. Forward Current (non-saturated) normalized to 1 mA at 25 °C




Fig. 14 - Cut-off Frequency (- 3 dB) vs. Collector Current




Fig. 15 - F<sub>CTR</sub> vs. Phase Angle




Fig. 16 - Switching Time vs. Load Resistance







Fig. 17 - Voltage Gain vs. Cut-off Frequency




Fig. 18 - Tape and Reel Shipping Medium (1000 units per reel)




Fig. 19 - Tape and Packing for Option 7
